

PUBLIC NOTICE Local Appointments List

The List contains names of all appointments to ongoing boards, commissions and committees which are appointed by each member of the City Council. Under Ordinance No. 2273, each City Councilmember has the power to appoint one (1) commissioner each to the Human Resources Commission and the Planning Commission, and two (2) commissioners to the Community and Senior Services Commission. Commissioners must be 18 years of age or older and a resident of the City of West Covina.
