

**RESOLUTION NO. 2018-134**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST COVINA, CALIFORNIA CASTING ITS VOTES FOR COUNCILMEMBER VALERIE MUNOZ OF THE CITY OF LA PUENTE TO REPRESENT CITIES WITHOUT PRESCRIPTIVE WATER PUMPING RIGHTS ON THE BOARD OF THE SAN GABRIEL BASIN WATER QUALITY AUTHORITY**

**WHEREAS**, on September 22, 1992, Senate Bill 1679 was signed into Law by Governor Pete Wilson authorizing the creation of the San Gabriel Basin Water Quality Authority; and

**WHEREAS**, the San Gabriel Basin Water Quality Authority is composed of seven members, with three appointed members from each of the three municipal water districts, one elected City Councilmember from cities in the San Gabriel Basin with prescriptive water pumping rights, one elected City Councilmember from cities in the San Gabriel Basin without prescriptive water pumping rights, and two members representing water producers in the San Gabriel Basin; and

**WHEREAS**, the City of West Covina is one of the cities in the San Gabriel Basin without prescriptive water pumping rights and is allotted eleven (11) votes; and


**WHEREAS**, the City of West Covina may cast its eleven (11) votes for a representative by resolution no later than December 18, 2018, at 12:00 p.m.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WEST COVINA DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:**


**SECTION 1.** The City Council of West Covina casts its eleven (11) votes for Councilmember Valerie Munoz of the City of La Puente as the representative for cities in the San Gabriel Basin without prescriptive water pumping rights.

**SECTION 2.** The City Clerk of the City of West Covina is directed to attest to this Resolution which shall thereupon become in full force and effect.


