

**RESOLUTION NO. 2019-81**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST COVINA, CALIFORNIA, ADOPTING A BUDGET AMENDMENT FOR THE FISCAL YEAR COMMENCING JULY 1, 2019 AND ENDING JUNE 30, 2020 (2019-2020 SLESA FUNDS)**

**WHEREAS**, the City Manager, on or about June 18, 2019, submitted to the City Council a proposed budget for the appropriation and expenditure of funds for the City of West Covina for Fiscal Year 2019-2020; and

**WHEREAS**, following duly given notice and prior to budget adoption, the City Council held a public meeting on June 18, 2019, receiving, considering and evaluating all comments, and adopted a budget for the fiscal year commencing July 1, 2019 and ending June 30, 2020; and

**WHEREAS**, amendments must periodically be made to the budget to conform to changed circumstances following adopting of the budget.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WEST COVINA DOES RESOLVE AS FOLLOWS:**

**SECTION 1.** That the budget amendments for Fiscal Year 2019-2020 are hereby approved as reflected in Exhibit 1 attached hereto.


**SECTION 2.** That this resolution shall be effective immediately upon passage and adoption.

**SECTION 3.** The City Clerk shall certify to the adoption of this Resolution.




