

PUBLIC NOTICE
Local Appointments List

The City of West Covina posts its Local Appointment List by December 31st of each year in compliance with the requirements of the Maddy Act (Government code Section 54970). The List contains names of all appointments to ongoing boards, commissions and committees which are appointed by each member of the City Council. Under Ordinance No. 2273, each City Councilmember has the power to appoint one (1) commissioner each to the Human Resources Commission and the Planning Commission, and two (2) commissioners to the Community and Senior Services Commission. The four members of the public appointed to the Finance and Audit Committee will be appointed by the City Council as a whole. Commissioners shall be at least eighteen (18) years of age and be a resident and registered voter of the city at the time of his or her appointment and throughout their term of office.
